Full Terms and Conditions

General Service Terms and Conditions:

- 1.1. By purchasing services through this platform, you agree to abide by these terms and conditions.
- 1.2. Our services include videography and related production services, as detailed in your purchase.
- 1.3. Payment: You agree to pay the specified amount for the chosen service package upon checkout.
- 1.4. Booking Confirmation: Your booking is confirmed only upon receipt of full payment.

Project Details:

- 2.1. The scope of work, deliverables, and timeline are as agreed upon in the project proposal or contract.
- 2.2. The client will be given the opportunity for one free revision session. Any further revisions requested by the client will be subject to an additional fee of £35 an hour and will require written approval.
- 2.3. Any requests for additional work will be subject to additional fees and will require written approval.

Cancellation & Rescheduling:

- 3.1. Client-initiated cancellation must be clearly and reasonably communicated in writing.
- 3.2. If a cancellation occurs within 14 days of the project start date, a fee of 40% of the original invoice will be charged due to time committed.
- 3.3. Rescheduling must be clearly and reasonably communicated in writing. If a project is rescheduled within 14 days of the project start date, a fee of 15% of the original invoice will be charged due to time committed.
- 3.4. If 66 Days is unable to meet the reschedule of the client, 66 Days has the right to terminate the contract.

Liability & Indemnity:

- 4.1. 66 Days will not be held liable for any direct, indirect, or consequential damages arising from the use or inability to use the delivered content.
- 4.2. The client agrees to indemnify and hold our company harmless from any claims, damages, or losses related to the produced content or its use.

Intellectual Property:

- 5.1. All intellectual property rights, including copyrights, related to the produced video content, shall remain the sole property of 66 Days.
- 5.2. Upon full payment, the client is granted a non-exclusive, worldwide license to use the delivered content for the agreed-upon purposes outlined in the project proposal or contract.
- 5.3. The client shall not modify, reproduce, distribute, publicly display, or exploit the content beyond the agreed-upon purposes without prior written consent from 66 Days.
- 5.4. 66 Days retains the right to request appropriate attribution in the form of a credit line or watermark on the video content, unless otherwise agreed upon in writing.
- 5.5. 66 Days may showcase the produced video content in its portfolio and promotional materials, online and offline, unless otherwise agreed upon in writing.

Confidentiality:

- 6.1. All information shared with 66 Days will be treated as confidential and will not be disclosed to third parties without prior written consent, except as required by law.
- 6.2. 66 Days may use client project information for internal purposes, portfolio showcases, and promotional materials, with due care to maintain confidentiality.

Dispute Resolution:

- 7.1. In the event of any dispute or disagreement arising from our services, both parties agree to engage in good faith negotiations to resolve the matter amicably.
- 7.2. If a resolution cannot be reached through negotiations, the parties agree to pursue mediation or alternative dispute resolution methods before resorting to litigation.

Late payments will incur a penalty of 5% of the final fee, unless otherwise clearly and reasonably communicated in advance with 66 Days.
